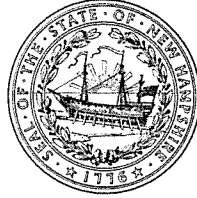

Re: DE 14-055 Revised to DE 12-200, Powerhouse Systems, Inc. – Weston Dam

Dear Mr. Cloutier:

On July 10, 2012, Hydro Management Group, LLC (Hydro Management) submitted an application requesting Class IV certification for Powerhouse Systems, Inc. Weston Dam Hydroelectric Facility (Weston Dam) pursuant to RSA 362-F, New Hampshire's Renewable Portfolio Standards law. On July 30, 2012, the Commission approved the Weston Dam as a Class IV renewable energy source effective July 10, 2012 in docket DE 12-200.

On February 27, 2014, the Commission received an application from Power House Systems requesting Class II New Hampshire Renewable Energy Certificate (REC) eligibility for the 0.044 megawatt (MW) Weston Dam Solar photovoltaic (PV) array that will be part of the Andrew Locke – Hydro Management Group's¹ approved aggregation pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law. This request was assigned docket number DE 14-055.

Staff has recommended that the Commission's review of the Weston Dam PV project's request for Class II certification be completed under the original docket, DE 12-200, to allow all the information and correspondence regarding the Weston Dam facility location to be under one case number. This is in keeping with past projects that have requested certification under different classes or have been denied eligibility due to compliance issues and then were reinstated when compliance was achieved.


