Dear Mr. Cloutier:

On February 27, 2014, the Commission received an application filed by Power House Systems. The applicant requested Class II New Hampshire Renewable Energy Certificate (REC) eligibility for the 0.044 megawatt (MW) Weston Dam Solar photovoltaic (PV) array. This array will be part of the Andrew Locke – Hydro Management Group's (Hydro Management Group) approved aggregation pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law.²

The Commission, in a non-adjudicative process, is required to issue a determination of whether a facility meets a particular classification within 45 days of receipt of a completed application. The above-named facility is a customer-sited source and meets the Class II eligibility requirements under RSA 362-F:4, II. Based on review of the application Staff recommends Commission approval for Weston Dam Solar as an eligible Class II facility to be included in the Hydro Management Group aggregation, effective as of February 27, 2014.

Because this facility is a customer-sited source, its output is not recorded in the ISO New England Market Settlement System and, as a result must be monitored and verified by an independent monitor. The application states that Paul Button of Energy Audits Unlimited will monitor the output of this facility and will report the facility's output quarterly to the NEPOOL Generation Information System (GIS) and annually to

the customer and the Commission as part of Hydro Management Group's Class II aggregation pursuant to N.H. Code of Administrative Rules Puc 2505.08 and 2505.09.
