Miscellaneous Tariff Revisions

Dear Mr. Hoepper:

On July 13, 2012, Pennichuck Water Works, Inc. (Pennichuck) submitted a new NHPUC Tariff 6 WATER in order to update its tariff to reflect, among other things, current Commission regulations including a new section 14 that incorporates the Medical Emergency Rules set out in NH Code of Admin. Rules Puc 1205, Pennichuck's current practices and procedures, and eliminate previously cancelled pages.

On October 25, 2012, Staff filed a recommendation that the proposed changes contained in Pennichuck's Tariff NHPUC No.6 WATER be approved and allowed to take effect with certain minor adjustments noted in its recommendation. Staff further noted that, inasmuch as the proposed changes will not have a financial impact on customers other than as a result of the Medical Emergency Rules, that the Commission could approve the tariff revisions by Secretarial Letter.

Please be advised that the Commission has accepted Staff's recommendation. Accordingly, pursuant to RSA 387:3, the proposed tariffs filed by Pennichuck and modified pursuant to Staff's recommendation have been approved.
