This letter is in reference to the application for renewal of registration as a natural gas aggregator filed by Good Energy, L.P. (Good Energy) on July 23, 2012.

Commission Staff, after filing an initial recommendation for approval of Good Energy's renewal application on August 16, 2012, filed an updated Staff recommendation regarding Good Energy's application on August 17, 2012. In its updated recommendation, Staff requested that the Commission suspend its consideration of Good Energy's renewal application during the pendency of the open Commission investigation involving Good Energy's electric aggregation activities, in Docket No. DE 12-214.

The Commission has approved Staff's request, and will therefore suspend its consideration of Good Energy's renewal application in Docket No. DM 12-222 until such time that the issues in Docket No. DE 12-214 are satisfactorily resolved. Please note that the current registration of Good Energy as a natural gas aggregator remains effective through October 31, 2012.
