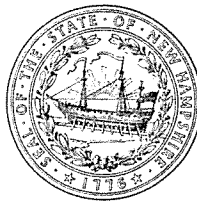

Withdrawal of Registration as a Natural Gas Aggregator

Dear Mr. Pulling:

On July 18, 2014, you filed a request with the Commission to withdraw the registration of inCharge, LLC (inCharge) as a natural gas aggregator in New Hampshire, effective as of June 30, 2014. In your letter you stated that InCharge has no natural gas customers, and you represented that inCharge has not served any retail natural gas customers during the past 90 days.

The Commission's rules governing natural gas aggregators do not provide for the withdrawal, rescission or abandonment of an aggregator's registration. The Commission has reviewed your letter and has deemed it a request for waivers of N.H. Code Admin. Rules Puc 3003.04(f) (approved aggregator registration valid for two years), and Puc 3003.04(h) (registered aggregator to continue compliance with requirements of Puc 3000). The Commission has determined that the requested waivers, without any further conditions, are in the public interest and will not disrupt the orderly and efficient resolution of matters before the Commission, and that the purpose of the rules will be satisfied by the termination of inCharge's natural gas aggregator registration, effective as of the date specified in the request letter.

Accordingly, inCharge's natural gas aggregator registration is deemed withdrawn and terminated, effective as of June 30, 2014.
