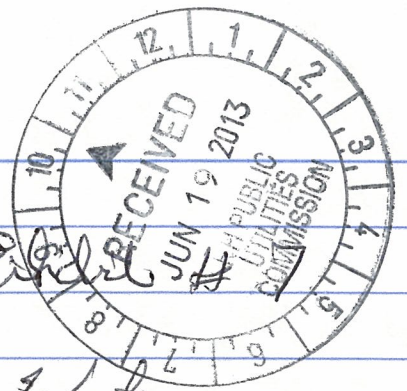

8. First the water Co must show each customer where their Curb Cock Valves is, and as no cleaning has been done for many years, the shut off valves may not function due to the (2)

neglect of the Co to Turn them
on & off yearly as per DES Water
Board. When and if the Co locates
each customers individual shut off
at the street R.O.W. and installs
Blow off valves at the end of each
main or at least 1 Blow off valve
equal to no more than every 1000 ft.
