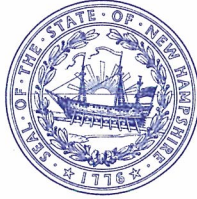

To the Parties:

The Settlement Agreement, approved on December 14, 2012, in the above referenced proceeding, and the subsequent approval in Order No. 25,462 (02/01/12), states that by April 30, 2013, Unitil Energy Systems (Unitil) shall determine whether to seek Commission approval of their proposed combined heat and power pilot measure. On April 24, 2013, Staff and the parties filed a request for an extension stating that discussions are ongoing and request an additional two weeks.

The Commission has determined that granting the extension will not unduly delay the proceeding or adversely affect the rights of any party. Accordingly, the request has been granted.
