Dear Mr. Wiers:

The application for Satori Enterprises LLC to register as a natural gas aggregator was received on September 11, 2012. Staff of the New Hampshire Public Utilities Commission (Commission) has completed its initial review of the registration application. The submitted application was incomplete and is therefore deficient in its current form.

Satori Enterprises LLC should address the following Commission requirements as appropriate in either its cover letter and/or in an update to its registration application:

- Puc 3003.04(a) No aggregator shall enroll customers, or arrange to sell to or contact customers, or solicit specific customers for such purposes until such aggregator has completed all aspects of registration required by PUC 3003;
- Puc 3006.02(a)(5) A copy of the applicant's current certificate of authority to do business in the State of New Hampshire from the Secretary of State, if anything other than an individual;
- Puc 3006.02(a)(6) A list of the CNGSs in New Hampshire through which the applicant may provide service;

Specifically, the applicant's submitted registration application did not acknowledge in its cover letter that it was in compliance with Puc 3003.04(a). In the event the applicant is not in compliance with this requirement, an explanation should be provided that provides an explanation as to why it is not in compliance with the requirement.

Additionally, the applicant's submitted registration application did not address the requirements of Puc 3006.02(a)(5) to include a copy of its current certificate of authority to do business in the State of New Hampshire from the Office of the Secretary of State. Finally, in part Puc 3006.02(a)(6) the application identified a CNGS by using an incomplete, or otherwise incorrect name of an entity that in this example is registered under two separate but different CNGS identities.
