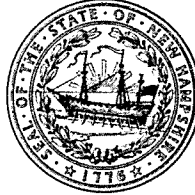

Dear Mr. Fossum:

On November 17, 2014, Public Service Company of New Hampshire (PSNH) filed a compliance report pursuant to Order No. 25,699 (July 31, 2014) in the above-captioned docket. The report included information provided on a confidential basis that listed the name of each competitive supplier entitled to a refund and the amount of the refund. The Commission will maintain this information as confidential pursuant to New Hampshire Code Admin. Rules Puc 201.04 (b).

The report was accompanied by a separate filing in which PSNH identified certain competitive suppliers that had not received refunds pursuant to Order No. 25,699. In its filing, PSNH provided, on a confidential basis, reasons for its inability to complete the reconciliation and requested that the Commission provide guidance on how the refund should be administered for these entities. Inasmuch as these suppliers are involved in bankruptcy proceedings, the Commission takes no position on how PSNH should handle refunds to these entities and defers to the bankruptcy court in that regard.

Finally, the Commission has found that PSNH is in substantial compliance with the Order No. 25, 699. PSNH shall inform the Commission regarding the final disposition of the pending refunds.
