To the Parties:

On December 3, 2012, New England Power Company d/b/a National Grid (NEP) filed its report on the reconciliation of its Contract Termination Charges (CTC) billed to Granite State Electric Company d/b/a Liberty Utilities (Liberty) for the period October 1, 2011 through September 30, 2012. Liberty's retail rate adjustments were approved in DE 12-341, Order No. 25,446 (December 27, 2012). The order states that a separate docket (DE 12-348) would be opened to allow Staff time to conduct a review of the proposed stranded cost charge. On December 31, 2012, Staff filed a memorandum indicating that the documentation provided by NEP supports the proposed 0.150 cents/kWh stranded cost charge for 2013 and that no adjustments are required.

Inasmuch as no further action on the part of the Commission is required, Docket No. DE 12-348 has been closed.
