Dear Ms. Howland:

Enclosed for filing with the commission are eight copies of the company's new tariff, setting forth an increased rate. The increase is to the customer charge and usage charge, and increases those charges from \$18.58 to \$42.55 per customer per quarter and from .4728 dollars to 1.0811 dollars per hundred gallons. The revision will increase the revenue of the company by \$23,844.00 per year, or 129% over present revenue. The tariff revision is to be effective on March 13, 2013.

Colin F. Robertson, Mary R. Robertson and Philip A. Brouillard are the officers of the corporation, and receive no compensation. Colin F. Robertson and Mary R. Robertson own all of the stock of the company. I am the officer in charge of the utility accounts. I affirm, based upon my personal knowledge, information and belief, that the cost and revenue statements and the supporting data submitted, which purport to reflect the books and records of the company, do in fact set forth the results shown by such books and records and that all differences between the books and the test year data and any changes in the manner of recording an item on the utility's books during the test year, have been expressly noted.


