THIRD: It is incorporated under the laws of State of Maine.

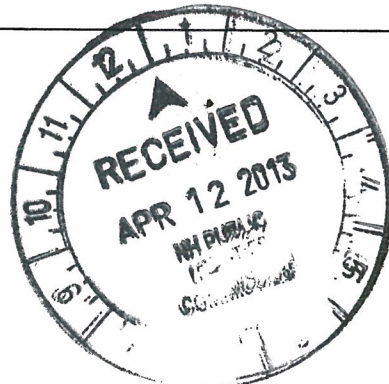
FOURTH: The date of its incorporation is April 14, 1950 and the period of its duration is on going.



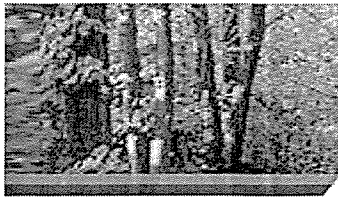
