Dear Mr. Short:

On July 08, 2013, the PUC received your application on behalf of Camelot Wind, LLC requesting that the Camelot Wind #1 turbine be granted eligibility as a Class I facility pursuant to RSA 362-F, New Hampshire's Renewable Portfolio Standard law. Staff has determined the application was complete in the initial filing received July 08, 2013.

The Camelot Wind #1 turbine is located in Plymouth, Massachusetts and is comprised of one, 1.5 megawatt wind turbine generator; the facility passed its NSTAR acceptance test on November 08, 2012. The application for Camelot Wind, LLC provided evidence of approvals from multiple regulatory agencies including federal, state, and local entities. Camelot Wind #1's renewable electricity generation is interconnected to the NSTAR Electric Company's (NSTAR) distribution line located along Camelot Drive. The ISO-New England asset identification number is MSS 42344.

The Commission has reviewed the Camelot Wind, LLC application for RECs and determined that all necessary documentation has been provided to demonstrate this facility meets all the requirements of Puc 2502.02 and is eligible for certification as a New Hampshire Class I facility. Therefore, the Commission hereby certifies the electrical generation from Camelot Wind #1 as a Class I renewable energy source effective July 08, 2013.

Attached please find a copy of the notice of this certification provided to the GIS administrator. The New Hampshire Renewable Portfolio Standard certification code for Camelot Wind #1 is NH-I-13-062.
