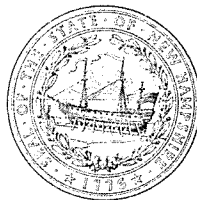

Dear Mr. Plutzer:

On July 18, 2013, Resource Energy Systems, LLC (Resource Energy) filed an application with the Commission to register as a provider of electric aggregation service.

Resource Energy was previously registered as a provider of electric aggregation service, but the company did not submit a timely renewal application and the registration period expired on December 19, 2012. Resource Energy has asked the Commission to accept its current filing as a new application. Staff also recommended that the filing be considered an initial application.

Based upon the foregoing, the Commission approves your application to register as a provider of electric aggregation service, effective July 26, 2013. The registration is for a term of 2 years and expires at the end of business on July 25, 2015. Pursuant to N.H. Code Admin. Rule Puc 2003.05(a), you must submit your next renewal application at least 60 days prior to the expiration of the registration approved here, on or before May 26, 2015.

Please be aware that registered providers of electric aggregation service are subject to specific requirements contained in N.H. Code Admin. Rules Puc 2000 – Competitive Electric Power Supplier and Aggregator Rules. These rules are available at: <http://www.puc.nh.gov/Regulatory/Rules/PUC2000.pdf>.
