Dear Secretary Howland:

Enclosed please find the original and six copies of a Joint Request for Waiver of N.H. Code Admin. Rule Puc § 303.02 ("Joint Request") on master metering. The Joint Request is made by Newbury Elderly Housing, Inc. and Community Action Program Belknap-Merrimack Counties, Inc. (hereinafter "BM-CAP"). As explained in the Joint Request, BM-CAP is developing an elderly housing project in Newbury, New Hampshire. The project will be owned by Newbury Elderly Housing, Inc., but the project will be operated by BM-CAP. The low income residents' rents will be subsidized, with heating, cooling and utilities included in their rents.

The grant of a waiver of the master metering prohibition for this housing project would serve the public interest. A similar request for waiver was granted by the Commission in Docket No. DE 10-067.
