

SERVICE AGREEMENT

This Service Agreement dated as of March 31st, 2015, is entered into by and between Massachusetts Electric Company ("Company"), a Massachusetts corporation and Liberty Utilities (Granite State Electric) Corp., a New Hampshire corporation ("Customer").

The Company agrees to provide and the Customer agrees to take and pay for Borderline Sales as specified in Appendix A hereto. The applicable rates for the Borderline Sales shall be as provided in the Company's retail delivery service tariffs as approved by the Massachusetts Department of Public Utilities and as in effect from time to time. Those tariffs and Appendix A hereto are incorporated herein and made a part hereof.

This Service Agreement, Appendix A to this Service Agreement, the Company's FERC Electric Tariff No. 1 and the Company's retail delivery service tariffs as approved by the Massachusetts Department of Public Utilities may be amended from time to time as provided in paragraph F of Schedule I of the Company's FERC Electric Tariff No. 1.

APPENDIX A

Borderline Sales Specifications:

1. Borderline sales shall be provided on behalf of Customer at the following Delivery Point(s): 12 Freeman Lane, Salem, New Hampshire
2. Applicable Rates: Residential Regular R-1
3. Special Provisions Applicable to the Customer (if any): The Company shall maintain and own all equipment necessary for delivery of service to the Delivery Point, excluding the meter which the Customer shall own. In addition, the Company shall use all reasonable efforts to promptly restore power to the Delivery Point upon notice of an outage, and upon request by the Customer shall provide the Customer an estimated time for restoration of service to the Delivery Point.

SERVICE AGREEMENT

This Service Agreement dated as of March 31st 2015 is entered into by and between Liberty Utilities (Granite State Electric) Corp. ("Company"), a New Hampshire corporation and Massachusetts Electric Company ("Customer"), and supersedes the Service Agreement entered into by the Parties on October 1, 2012.

The Company agrees to provide and the customer agrees to take and pay for Borderline Sales as specified in Appendix A hereto. The applicable rates for Borderline Sales shall be provided in the Company's retail delivery service tariffs as approved by the New Hampshire Public Utilities Commission and as in effect from time to time. Those tariffs and Appendices A and B hereto are incorporated herein and made a part hereof.

This Service Agreement, Appendices A and B to this Service Agreement, the Company's FERC Electric Tariff No. 2 and the Company's retail delivery service tariffs as approved by the New Hampshire Public Utilities Commission may be amended from time to time as provided in paragraph F of Schedule I of the Company's FERC Electric Tariff No. 2.
