Deficiency Letter

Dear Ms. Desai:

On February 6, 2014, Trusted Energy LLC submitted an application with the Commission to register as a provider of electric aggregation service. The application is incomplete and does not comply with the requirements of N.H. Code Admin. Rule Puc 2003. Commission Staff reviewed the filing and identified the following items which are missing from the application.

- 1) Certificate from the Secretary of State showing that the applicant is authorized to do business in New Hampshire.

*Puc 2006.02 Form for Initial and Renewal of Aggregators.*

*(5) A copy of the applicant's authorization to do business in New Hampshire from the secretary of state, if anything other than an individual.*

- 2) The geographic area in New Hampshire in which you intend to provide service.

*Puc 2006.02 Form for Initial and Renewal of Aggregators.*

*(6) Description of the geographic areas of New Hampshire in which the applicant intends to provide service.*

Regarding item #1, Commission Staff did note you provided an acknowledgement of your application to register with the Secretary of State's office. However, this does not demonstrate your authorization to do business in New Hampshire. In order to meet this requirement you should provide a copy of the certificate from that office stating you are registered to do business. The certificate includes a gold-colored seal. Note that you may


have to contact the Secretary of State's office to specifically request the certificate, as it may not be automatically provided to you upon approval of your application.

In order to complete your application you should respond accordingly to the items listed above. When responding, please address your letter to Debra A. Howland, Executive Director and reference the docket number listed on the subject line of this letter.

Pursuant to Puc 2003.04 (h), please provide all information requested within 60 days of the date of this letter, on or before **April 13, 2014**. Puc 2003.04 (h) is copied below.

*Puc 2003.04(h) If the commission has requested information or clarification to complete an application for registration, and such information or clarification is not provided within 60 days of the request, the commission shall suspend the application. If, after 120 days of the date of the request, the applicant has not provided the requested information or clarification, the commission shall reject the application. If an application is rejected, the application fee shall be forfeited and the applicant shall be required to submit a new application and fee prior to acting as an aggregator in New Hampshire.*
