Dear Mr. Hirsh:

On March 3, 2014 the Commission received applications filed by Solar Farm Bank, LLC (SFB) on behalf of Corin Wright (Wright), Lyn Lindpaintner (Lindpaintner) and Sam Pylypczuk (Pylypczuk) requesting Commission approval for New Hampshire Class II Renewable Energy Certificate (REC) eligibility for photovoltaic (PV) arrays pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law.¹ Certification of these facilities will enable SFB to add these facilities to its aggregation pursuant to Puc 2506.01 and ensure recognition by the Generation Information System (GIS) under NON 35889.²

The above-named facilities are customer-sited sources and meet the Class II eligibility requirements under RSA 362-F:4, II. Based on review of the applications, Staff has recommended that the Commission approve the Wright, Lindpaintner, and Pylypczuk PV arrays as part of SFB's Class II eligible facilities aggregation effective March 3, 2014.

Because these facilities are customer-sited sources, their output is not recorded in the ISO New England Market Settlement System and, as a result, must be monitored and verified by an independent monitor. The applications state that Paul Button of Energy Audits Unlimited will monitor the output of these facilities pursuant to N.H. Code of

Administrative Rules Puc 2505.08 and 2505.09. Mr. Button will report the total output of these facilities quarterly to the Generation Information System (GIS) and annually to the Commission as part of SFB's Class II aggregation under Puc 2505.09(h)(3). The GIS facility code assigned to SFB is NON 35889.

Please be advised that, pursuant to RSA 362-F, the New Hampshire Public Utilities Commission has certified the following photovoltaic (PV) Class II REC eligible facilities that will be part of the Solar Farm Bank aggregation (SFB) effective as of March 3, 2014: Corin Wright (Wright), Lyn Lindpaintner (Lindpaintner) and Sam Pylypczuk (Pylypczuk).
