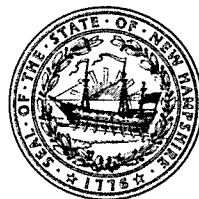

Dear Mr. McNeil:

On March 11, 2014, the Commission received applications filed by the New Hampshire Electric Cooperative (NHEC) for Brian Burke (Burke) and Eric Schott (Schott). NHEC is requesting Class II New Hampshire Renewable Energy Certificate (REC) eligibility for the Burke and Schott photovoltaic (PV) arrays pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law.¹ Staff has reviewed these applications and has recommended approval of these PV arrays as eligible for Class II RECs as listed in the following table:



¹ Class II eligibility requires a facility to produce electricity from solar technologies that began operation after January 1, 2006 (RSA 362-F:4, II).

Because these facilities are customer-sited sources, the output is not recorded in the New England Power Pool Market Settlement System and, as a result, the output must be monitored and verified by an independent monitor. The applications state that NHEC will monitor the facilities' output as required by N.H. Code of Administrative Rules Puc 2505.08 and 2505.09. The total output from these facilities will be included as part of the NHEC Class II Aggregation's total output reported to the NEPOOL Generation Information System as approved by the Commission on April 9, 2010.

The Commission has determined that NHEC has provided all the information necessary to demonstrate these facilities' eligibility for certification. The Commission hereby certifies the Burke and Schott photovoltaic arrays as eligible for Class II RECs to be included as part of the NHEC aggregation effective as of March 11, 2014.

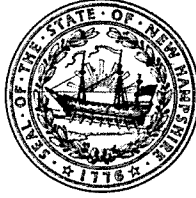

Please be advised that, pursuant to RSA 362-F, the New Hampshire Public Utilities Commission has certified the Brian Burke (Burke) and Eric Schott (Scott) residential photovoltaic facilities as part of the New Hampshire Electric Cooperative (NHEC) Class II aggregation.
