Please be advised that the New Hampshire Public Utilities Commission has certified Niagara Wind Power, LLC's 20 megawatt (MW) Steel Winds I - Wind Plant (Steel Winds I) as a Class I renewable energy source, effective as of March 13, 2014, pursuant to RSA 362-F:4, New Hampshire's Electric Renewable Portfolio Standard law. Accordingly, Steel Winds I is eligible to be issued New Hampshire Class I RECs as of such date, provided that certain additional confirmatory information is submitted to the Commission following the end of each calendar quarter.

Steel Winds I is located at in Lackawanna, New York, and is comprised of eight Clipper 2.5 MW turbines. The wind plant began operation on June 1, 2007. Approvals from the City of Lackawanna Planning Board provided assurance that the Steel Winds I wind facility is permitted in the State of New York.

The GIS facility code is IMP 32625. The New Hampshire Renewable Portfolio Standard certification code for Steel Winds I is NH-I-14-041.
