RE: DE 14-078 Electric Assistance Program

To the Parties:

On June 13, 2016, Public Service Company of New Hampshire d/b/a Eversource Energy ("Eversource") filed a motion requesting that the Commission grant "a waiver of the waiver in Order No. 25,901[,] requiring Eversource to implement certain Electric Assistance Program (EAP) rate changes on a bills-rendered basis. Instead, Eversource seeks to implement the rate changes on a service-rendered basis, which is consistent with the way its billing system functions.

The Commission has interpreted Eversource's motion as a request to modify Order No. 25,901 and, pursuant to RSA 365:28, authorized Eversource to implement the EAP rate changes on a service-rendered basis. For administrative efficiency, the Commission has elected to issue this Secretarial Letter as its order on Eversource's motion.
