Dear Mr. Murray:

On April 18, 2014, TDS Telecom (TDS) filed an Interconnection Agreement pursuant to 47 U.S.C. §252(e) with Freedom Ring Communications, LLC d/b/a BayRing Communications (BayRing). BayRing elected to adopt the Interconnection Agreement between TDS and Comcast Phone of New Hampshire, LLC (Comcast) pursuant to 47 U.S.C. §252(i).

The Commission elects to take no action on this petition. Accordingly, pursuant to 47 U.S.C. §252(e)(4), the adoption of the Interconnection Agreement will take effect by operation of law 90 days after its filing, on July 17, 2014. Notwithstanding the foregoing, any clause in the Agreement found to be in violation of any Commission order is null and void.

The Commission has updated its records to include the adoption of this agreement. Docket No. DT 14-109 has been assigned for future reference.
