**RE: Northland Telephone Company of Maine, Inc. d/b/a FairPoint Communications - Northland Telephone Company of Maine - Revision to NHPUC Tariff No. 2 (Switched Access Services)**

Dear Ms. Howland:

Enclosed for filing, please find the original and six (6) copies of the above referenced tariff revision submitted on behalf of Northland Telephone Company of Maine, Inc. d/b/a FairPoint Communications - Northland Telephone Company of Maine. This filing is submitted in compliance with Phase III of the ICC reform requirements mandated by Federal Communications Commission Report and Order in WC Docket No. 10-90, etc., FCC No. 11-161 (released Nov 18, 2011).

In addition to billing a single composite rate as terminating local end office switching, FairPoint has combined the per minute End Office – Local Switching rate and the End Office – Information Surcharge for originating traffic into a composite rate. There is no revenue impact with this change. By combining these two rate elements, the originating rate structure will mirror the terminating rate structure for the end office per minute rate elements. FairPoint will use the End Office Originating Local Switching rate element as the vehicle to bill this composite rate.

The Company respectfully requests an effective date of July 1, 2014.


