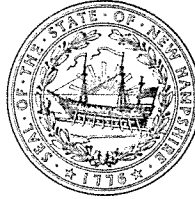

Re: DT 14-160: Intrastate Access Rate Tariff Filings by CLECs

Dear Ms. Thomas:

On July 17, 2014, ACN Communications Services, Inc. (ACN) submitted a filing to revise its intrastate access tariff, pursuant to the Federal Communications Commission (FCC) Report and Order FCC 11-161 (Transformation Order).

Staff reviewed the proposed tariff changes for compliance with FCC orders and rules, and following its investigation, recommended that these proposed changes be allowed to take effect on July 31, 2014.

The Commission has accepted Staff's recommendation that the proposed tariff changes be allowed to take effect. For administrative efficiency, an order will not be issued by the Commission either suspending, rejecting, or approving the proposed tariff changes. Pursuant to RSA 378:3 and RSA 378:6, IV, the proposed tariff changes, filed on July 17, 2014, and pursuant to Staff's recommendation, are effective on July 31, 2014. Tariff pages should be filed referencing Docket No. DT 14-160 and reflecting the effective date of July 31, 2014.
