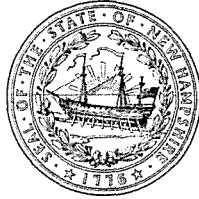

RE: DT 14-160: 2014 Intrastate Access Rate Tariff Filings by CLECs

Dear Mr. Roesel:

On July 17, 2014 we received a letter and attachment you described as a tariff filing for Neutral Tandem-New Hampshire, LLC (Neutral Tandem).

New Hampshire RSA 378:1 requires that a public utility submit tariffs or schedules "showing the rates, fares, charges, and prices for any services rendered." This filing does not provide such information, and instead refers the reader to rates published elsewhere. (For example, see Page 16, Note 1). This does not meet the requirements of state law.

Staff will treat the filing of July 17th as an incomplete proposed tariff revision. Once we receive a complete filing, specifically including the actual rates proposed, review of the filing pursuant to RSA 378:6 shall commence.
