Freedom Ring Communications, L.L.C. (BayRing) submitted a proposed access tariff revision on December 22, 2014. The revision corrects a typographical error in its July 31, 2014, access tariff in which a decimal point was missing. The access rate BayRing had intended to list, and which it has been charging customers, is \$0.003281 per minute. The revision simply inserts the period.

In Staff's assessment, the missing period was a clear and simple typographical error. Under Federal Communications Commission (FCC) rules and orders, the current cap on CLEC rates in New Hampshire is actually \$0.003281. The rate could not have been \$3281.

Staff recommends that the revision be allowed to take effect on January 25, 2015, bringing the published tariff into agreement with practice and law.
