On June 23, 2014, the Commission received an application from Knollwood Energy of MA, LLC (Knollwood Energy) requesting Class II New Hampshire Renewable Energy Certificate (REC) eligibility for the Erik Gelinias (Gelinias) photovoltaic (PV) array and inclusion in the Knollwood Energy aggregation. The Commission approved the Gelinias facility for Class II REC eligibility and inclusion in the Knollwood Energy aggregation (effective as of June 23, 2014), on July 7, 2014.

Upon further review, the Commission has noted that the New Hampshire Certification Code listed as NH-II-14-072 in the July 7, 2014 approval letter is incorrect. The correct New Hampshire Certification Code and details for this facility are listed in the following table.
