The Commission received and staff reviewed the Littleton Regional Healthcare (LRH) application requesting full Class I Thermal eligibility for the LRH 3.517 megawatt equivalent thermal biomass facility. This facility had previously been approved for interim Class I-T certification while it was in the process of implementing the metering requirements of Puc 2500. Based on Staff recommendation, the Commission hereby approves the biomass facility as fully eligible for Class I-T REC eligibility effective as of September 8, 2015.
