Dear Mr. Fisher:

On July 14, 2014, Ultimate Energy Advisors, LLC (Ultimate Energy) submitted an application with the Commission to renew its registration as a provider of electric load aggregation service. Ultimate Energy's previously active registration expired on April 9, 2014. Staff informed Ultimate Energy that its registration had expired three months earlier and that its application would be processed as an initial registration.

The Commission has approved Ultimate Energy's application for an initial registration to provide electric load aggregation service, effective as of September 11, 2014. The registration is for a term of two years and expires at the end of business on September 10, 2016. Pursuant to N.H. Code Admin. Rule Puc 2003.05(a), you must submit your next renewal application at least 60 days prior to the expiration of the registration approved here, on or before July 13, 2016.

Please be aware that registered providers of electric aggregation service are subject to specific requirements contained in N.H. Code Admin. Rules Puc 2000 – Competitive Electric Power Supplier and Aggregator Rules. These rules are available at: <http://www.puc.nh.gov/Regulatory/Rules/PUC2000.pdf>. Please also be aware that the Commission has opened Docket DRM 13-151 to consider revisions to these rules. All non-confidential filings in Docket DRM 13-151 can be found at <http://www.puc.nh.gov/Regulatory/Docketbk/2013/13-151.html>. The revised rules may contain different requirements for maintaining registration as a provider of electric aggregation service that might affect your registration.
