On July 16, 2015, the Joint Legislative Committee on Administrative Rules (JLCAR) voted to conditionally approve Final Proposal 2015-14 from the Public Utilities Commission (Commission) relative to the Puc 2100 Rules for Affiliate Transactions. The conditional approval requested the following:

Moving and renumbering the text of Puc 2105.04(e)(9) and (10) to become Puc 2105.04(c)(24) and (25);

Amending and renumbering Puc 2105.01 to add (f) and (h) as specified in the Commission's conditional approval request dated July 13, 2015; and

Amending Puc 2106.05(a) as specified in the Commission's conditional approval request dated July 13, 2015.

The Commission met today in public meeting and voted to accept the conditional approval. A copy of the rule amended in accordance with the conditional approval is enclosed with annotations that reflect the language requested by the JLCAR. Thank you for your assistance in this matter.
