

Granite State Hydropower Association hereby submits the following written updates and additions to the Prefiled Direct Testimony of Richard A. Norman (Exhibit K) and Supplemental Prefiled Direct Testimony of Richard A. Norman (Exhibit L) which Mr. Norman made orally at the February 3, 2015 hearing in the above-captioned matter:

Add the following sentence to Exhibit K, page 8, line 18:

“Also, FERC has declared that an energy imbalance service market rate at a QF’s node is not the purchasing utility’s avoided cost under PURPA. *See* Excelon Wind 1, LLC et al, 140 FERC ¶61,152 (issued August 28, 2012).

Substitute the following sentence for that appearing in Exhibit K, page 12, lines 2 to 3:


“For example, for the period January 1, 2015 to December 31, 2015, the average RT prices were 4.51% less than the average DA prices.”

Ass the following sentence to Exhibit L, page 5, line 2 after the words “purchase power)”:

“PSNH’s average generating costs in 2015 were 6.71 cents/kWh, while the average RT
NH LMP energy price for the same period was 4.02 cents/kWh.”


