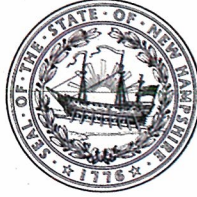

Dear Ms. Howland:

On December 5, 2014, a technical session was held involving representatives of Dixville Telephone Company (Dixville), New Cingular Wireless PCS, LLC (AT&T Mobility), and Commission Staff, to review the status of efforts to resolve relevant issues and to discuss the future procedural schedule for this proceeding.

The parties discussed the status of ongoing negotiations for a potential sale transaction involving a third party that would obviate the need for adjudication of Dixville's petition, and the parties agreed that the public hearing should be cancelled and the procedural schedule suspended until the results of these negotiations are known. Staff will continue to monitor these developments and will report to the Commission regarding the need to continue this proceeding all as circumstances warrant.

Staff, on behalf of the parties, respectfully requests that the Commission cancel the public hearing scheduled for December 11, 2014 and approve the proposed suspension of the procedural schedule for this docket. I certify that a copy of this letter will be served electronically on the parties on the service list at the same time it is filed with the Commission.
