On October 20, 2014, the Commission received additional applications filed by NHEC requesting Class II eligibility for NHEC member PV arrays and inclusion in the NHEC aggregation. These applicants include Charles Darling (Darling), Kent Island Trust – Charles Barnaby (Barnaby), Vicki Smith (Smith), Ryan Murphy (Murphy), Edibeth Farrington (Farrington), Karl Vornberger (Vornberger), Patrick Kelly (Kelly), Brian Colp, (Colp), and Mike Mikkelsen (Mikkelsen).


Staff has reviewed these applications and has recommended approval of these PV arrays as eligible for Class II RECs and inclusion in the NHEC aggregation as listed in the following table:

These facilities are customer-sited sources. Their output is reported as part of the NHEC aggregation to the New England Power Pool Generation Information System (NEPOOL-GIS) as NON32900<sup>1</sup>. In addition to reporting each source's output to the Commission, NHEC will include the total output of these facilities when it reports the total output of all of its Class II eligible facilities, under the name *NHEC Class II Aggregation*, to the NEPOOL-GIS. NHEC also serves as the Independent Monitor for these sources.<sup>2</sup>

The Commission has determined that NHEC has provided all the information necessary to demonstrate these facilities' eligibility for certification and hereby certifies the above named PV arrays as eligible for Class II RECs and inclusion in the NHEC aggregation effective as of the dates listed in the table above.

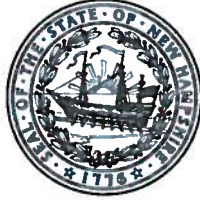


Please be advised that, pursuant to RSA 362-F, the New Hampshire Public Utilities Commission has certified the Raymond Gilpatric (Gilpatric), Michael Huntoon (Huntoon), John S. Derr (Derr), Christian Bisson (Bisson), Jim Bonney (Bonney), and Paul Estes (Estes) residential solar photovoltaic (PV) facilities as part of the New Hampshire Electric Cooperative (NHEC) Class II aggregation effective as of September 29, 2014.

In addition, the Commission has certified the Charles Darling (Darling), Kent Island Trust – Charles Barnaby (Barnaby), Vicki Smith (Smith), Ryan Murphy (Murphy), Edibeth Farrington (Farrington), Karl Vornberger (Vornberger), Patrick Kelly (Kelly), Brian Colp, (Colp), and Mike Mikkelsen (Mikkelsen) facilities as part of the NHEC Class II aggregation effective as of October 20, 2014.
