**AUTHORIZATION FOR CLASS I- THERMAL RENEWABLE  
ENERGY CERTIFICATE (REC) ELIGIBILITY**

The Commission received and staff reviewed the application requesting Class I Thermal eligibility for **the Canaan Elementary School** biomass facility. Based on Staff's recommendation, the Commission has approved the 0.112 Megawatt equivalent facility as eligible for Class I Thermal RECs<sup>1</sup> effective as of February 27, 2015. In addition, based on Staff's recommendation, the Commission has approved the facility's inclusion in the Wilson Engineering Services, PC aggregation<sup>2</sup>.
