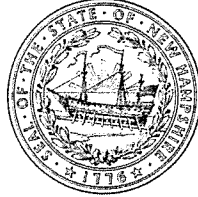

Dear Ms. Morgan:

Mega Energy of New Hampshire, LLC (Mega Energy) filed an Annual Renewable Portfolio Standard (RPS) Compliance Report with respect to the 2014 compliance year on June 30, 2015, pursuant to Puc 2503.03(a) and RSA 362-F:8. This report indicates that the sum of \$33,986 in alternative compliance payments (ACP) is due from Mega Energy for the 2014 compliance year. Pursuant to Puc 2503.03(c) and RSA 362-F:10, II, this amount was required to be paid to the New Hampshire Public Utilities Commission (Commission) at the same time as the filing of the Annual RPS Compliance Report, on or before July 1, 2015, either with a check made payable to the State of New Hampshire or through electronic transfer to the renewable energy fund bank account. To date, however, Mega Energy has paid only \$32,628 of the total of \$33,986 that was due by July 1, 2015; Mega Energy still owes \$1,358.

Please pay this amount in full within ten (10) days of the date of this letter. If full payment is not received by such date, then the Mega Energy ACP balance may be referred for collection to the New Hampshire Department of Justice. In addition, the Commission may initiate an adjudicative proceeding to impose penalty sanctions of up to \$1,000 per day for each violation of an applicable state statute, pursuant to Puc 2005.01(b).
