On July 16, 2015, the Joint Legislative Committee on Administrative Rules (JLCAR) voted to conditionally approve Final Proposal 2015-46 from the Public Utilities Commission (Commission) relative to the Puc 1800 Rules for Energy Conservation in New Building Construction. The conditional approval requested the addition of a citation to the website containing the New Hampshire State Building Code in 1801.05, the definition of "energy code."

The Commission met today in public meeting and voted to accept the conditional approval. A copy of the rule amended in accordance with the conditional approval is enclosed with annotations that reflect the language requested by the JLCAR.
