Scheduling of Hearing

To the Parties:

On September 9, 2005, the Commission issued Order No. 24,511 in Docket No. DE 05-064, Unitil Energy Systems, Inc. (Unitil) which, among other things, approved Unitil's solicitation process for procuring default service for its G-1 and Non-G1 customers. On October 2, 2015, Unitil filed a petition for approval of its default service solicitation, for the six-month period beginning December 1, 2015, of 100% of default service power requirements for its Non-G1 customers and G1 customers. With its filing, Unitil supplied the testimony and related exhibits of Todd M. Bohan and Linda S. McNamara, along with proposed tariffs.

The Commission will hold a hearing on Tuesday, October 6, 2015 at 10:00 a.m., at which time the Commission will hear the testimony of Mr. Bohan, Ms. McNamara and Commission Staff. This process is consistent with Order No. 24,511 at 15 which states that "when Unitil presents its Supply Agreement and the accompanying rates, we will review the rates pursuant to RSA 262:17-a."
