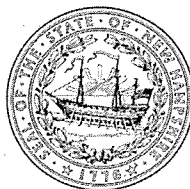

**AUTHORIZATION FOR CLASS IV RENEWABLE ENERGY
CERTIFICATE (REC) ELIGIBILITY**

The Commission received and staff reviewed the application requesting Class IV REC eligibility for the Old Nash Dam Hydroelectric facility owned by Marlow Hydro, LLC and operated by Anthony B. Rosario. Based on Staff's recommendation, the Commission has approved the 0.212 megawatt facility as eligible for Class IV RECs,¹ effective as of March 4, 2015.
