Renewal of Registration as Competitive Electric Power Supplier

Executive Summary

First Point Power has applied to renew its registration as a competitive electric power supplier. First Point Power's current registration expires June 4, 2015. First Point Power submitted a sample residential and small commercial customer contract, a certificate demonstrating it has completed EDI testing with Eversource Energy, Liberty Utilities, and Unitil Energy Systems, a continuation certificate extending, by one year, the term of its surety bond in the amount of \$350,000, and a request for a waiver of the five-year and 90-day term requirement for financial security. If the Commission were to grant the waiver, Staff believes the filing is acceptable. Staff recommends the Commission grant the waiver and approve the application, for service in the franchise areas of Eversource, Liberty, and UES, for a renewal registration period ending on the termination date of the surety bond as extended.

Background and Analysis

On March 19, 2015, First Point Power, LLC (First Point Power) filed an application to renew its registration as a competitive electric power supplier (CEPS). First Point Power's currently active registration, which the Commission approved in Docket No. DM 14-153, expires on June 4, 2015. First Point Power's application included a sample of a residential and small commercial customer contract and a certificate demonstrating that it has completed EDI testing with Eversource Energy (Eversource), Liberty Utilities (Liberty), and Unitil Energy Systems (UES). On March 25, 2015, First Point Power submitted a continuation certificate to its currently effective surety bond, which extends the term and expiration date of the surety bond to June 4, 2016, and a request for a waiver of Puc 2003.03(a)(5)(b), which requires that the financial security filed with a CEPS renewal application have a term of not less than five years and 90 days. The continued surety bond is in the amount of \$350,000 and names the Commission as beneficiary.

Staff has reviewed the information in the application and, if the Commission were to grant approval of the waiver request, believes it meets the requirements of Puc 2003

and 2006.01. Staff recommends that the Commission grant the request for a waiver of Puc 2003.03(a)(5), and, because the extended surety bond does not meet the five-year and 90-day requirement and because it expires on June 4, 2016, that the Commission approve a renewal registration period with a term concurrent with the extended surety bond, beginning on the expiration date of the currently active registration, June 5, 2015, and ending on June 4, 2016. Staff also recommends that, if the Commission grants the requested waiver, the Commission notify First Point Power that the financial security rules are likely to change during 2015 and that First Point Power should monitor the rulemaking process in Docket No. DRM 13-151 and plan accordingly with respect to future operations in New Hampshire.

Staff recommends that the Commission approve First Point Power's application to renew its registration as a CEPS, authorized to operate only in the service areas of Eversource, Liberty, and UES. If First Point Power seeks to operate in the service areas of other distribution utilities, it can do so by filing a request with the Commission to extend its service area, and by providing proof that it has completed EDI testing with each distribution utility in whose franchise area it requests authority to operate. Staff will then review the request and make a recommendation to the Commission.
