Re: DT 15-118, IDT Request for Waiver of Neustar Denial of Numbering Resources

Dear Mr. Auerbach:

IDT America Corp. (IDT) has petitioned the New Hampshire Public Utilities Commission (Commission) to grant a waiver of Neustar's decision to deny IDT's request for numbering resources in the Laconia New Hampshire rate center. IDT, which has OCN number 314C, submitted a request for numbering resources to Neustar on or about March 31, 2015. The request was denied based on IDT's utilization of existing numbers in the exchange. According to IDT, it cannot fulfill the customer's request with existing numbers.

Pursuant to the FCC's Numbering Resources Optimization Third Report and Order and Second Order on Reconsideration (FCC 01-362) Appendix A, Final Rules 52.15(g)(4) a state commission may overturn Neustar's decision to withhold numbering resources from a carrier if the state commission determines that the carrier has "demonstrated a verifiable need for numbering resources and has exhausted all other remedies."

The Commission staff has reviewed the petition and supporting material and recommended that a waiver for the request be granted. The Commission has found good cause exists, in this instance, to grant IDT's petition for a waiver and requests that the Pooling Administrator provide the numbering resources requested by IDT.
