On June 1, 2018, Better Cost Control, LLC (Better Cost Control) filed a request with the Commission to withdraw its registration as an electric load aggregator in New Hampshire.

Commission Staff filed a memorandum on June 4, 2018, summarizing its review of Better Cost Control's request and its determination that the request meets the requirements for approval of withdrawal of an electric load aggregator registration, pursuant to Puc 2003.08(b) and (c). Staff recommended that the withdrawal of Better Cost Control's electric load aggregator registration be approved, effective as of the date of the letter confirming such approval.

Your request to withdraw the electric load aggregator registration of Better Cost Control is approved, effective as of June 4, 2018, pursuant to Puc 2003.08(b) and (c). Accordingly, Better Cost Control's registration is deemed to be terminated as of that date.
