As you know, the Commission approved a procedural schedule in the above-captioned docket that scheduled a technical session on November 2, 2015.

At this point, Staff has not retained an engineering consultant on this docket. Based on that fact, Staff notified the parties yesterday that we would be requesting that the procedural schedule in this docket be stayed until such time as we can secure a consultant. No party has conveyed an objection to this proposal. Eversource agreed with the proposal to suspend the procedural schedule, and specifically to the cancellation of the November 2, 2015 technical session.

Therefore, Staff requests that the Commission suspend the procedural schedule in this docket and direct Staff to develop a schedule once we have retained the services of an engineer. Thank you for your attention to this matter.
