Request to revise procedural schedule

Dear Ms. Howland:

The next deadline in the procedural schedule of the Energy Efficiency Resource Standard (EERS) docket is November 2. Any EERS proposals for Commission consideration are due on that date. The Commission Staff (Staff), however, requires additional time to prepare its EERS proposal due to the demands of another pending docket, DE 14-238. Two Staff analysts are working on both DE 14-238 and the EERS docket.

Staff has discussed revising the EERS procedural schedule with the parties on the service list. No party objected to revising the procedural schedule so long as the testimony deadline was set on December 1 and the hearing dates remain unchanged. Because the procedural schedule in DE 14-238 is in flux, Staff and the parties must wait to propose the remainder of the revised procedural schedule. In the meantime, Staff and the parties request permission to reschedule the November 2 deadline to December 1, and to file a revised procedural schedule for the EERS docket as soon as the revised procedural schedule in DE 14-238 is finalized.
