Dear Ms. Howland:

Granite Telecommunications, LLC (“Granite”) submits to the New Hampshire Public Utilities Commission this notice of compliance with the Federal Communications Commission’s (“FCC”) *Report and Order and Further Notice of Proposed Rulemaking*, in Docket Nos. WC Docket No. 10-90, et al., FCC 11-161,¹ *Second Order on Reconsideration* in Docket Nos. WC Docket No. 10-90, et al., FCC 12-47,² and Sections 51.911(c) and 61.26(c) of the FCC’s rules, 47 C.F.R. §§51.911(c) and 61.26(c).

Granite complies with the above cited orders and rules by maintaining its intrastate terminating rates at parity with, or below, the corresponding incumbent local exchange carriers’ interstate rates in its operating territory that become effective July 1, 2015. Granite’s New Hampshire switched access tariff, New Hampshire P.U.C. Tariff No. 1, already reflects terminating access rates that are below The Fairpoint Telephone Company’s corresponding terminating interstate rates effective July 1, 2015, obviating the need for further intrastate tariff amendments to comply. 
