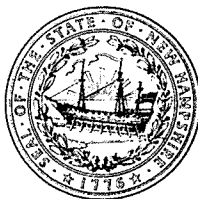

Re: DT 15-185: Union Telephone Company: Intrastate Access Tariff Revisions

Dear Ms. Ladwig:

On May 28, 2015, Union Telephone Company (Union) submitted a filing to revise its intrastate access tariff for effect on July 1, 2015, pursuant to the Federal Communications Commission (FCC) Report and Order FCC 11-161 (Transformation Order). Consistent with the Transformation Order as revised, the tariff filing proposes to set Union intrastate access rates equal to current Union interstate rates.

Staff reviewed the proposed tariff changes for compliance with FCC orders and rules, and following its investigation, recommended that these proposed changes be allowed to go into effect, with one revision. After consulting with Union, Staff reports that you both agree the rate for "6.8.1.Multiplexing (DS3 to DS1)" should be listed as \$447.12 rather than \$447.11.

The Commission has accepted Staff's recommendation that the proposed tariff changes be allowed to take effect with that revision. For administrative efficiency, an order will not be issued by the Commission either suspending, rejecting, or approving the proposed tariff changes. Pursuant to RSA 378:3 and RSA 378:6, IV, the proposed tariff changes, filed on May 28, 2015, and pursuant to Staff's recommendation, are effective, as proposed and revised, on July 1, 2015. Tariff pages incorporating the 6.8.1 revision should be filed referencing Docket No. DT 15-185 and reflecting the effective date of July 1, 2015.
