**Re: Compliance with 47 C.F.R. §51.915(d)(viii)(3) - Northern New England Telephone Operations LLC**

Dear Ms. Howland:

Enclosed for filing on behalf of Northern New England Telephone Operations LLC d/b/a FairPoint Communications – NNE (“FairPoint”) is an original and two copies of the Certification required in accordance with 47 C.F.R. §51.915(d)(viii)(3), adopted by the Federal Communications Commission in its Report and Order WC Docket Nos. 10-90 et. al., FCC No. 11-161 (November 18, 2011). This rule requires Price Cap carriers seeking revenue recovery to “annually certify as part of its tariff filings to the Commission [FCC] and to the relevant state commission that the carrier is not seeking duplicative recovery in the state jurisdiction for any Eligible Recovery subject to the recovery mechanism.”

FairPoint submitted its annual access filing to the New Hampshire Public Utilities Commission on May 28, 2015 and today under separate cover filed a correction to that tariff page. FairPoint respectfully requests the Commission approve that tariff for effect July 1, 2015.

Enclosed please find a redacted (public) version of the work documents and seven copies of the un-redacted (confidential) version of the work documents together with an original plus six copies of a motion seeking confidential treatment of certain information contained in the work documents supporting FairPoint Communications’ Certification.
