Dear Executive Director Howland:

On January 6, 2016, Lakes Region Water Company, Inc., filed a *Memorandum in Support of Settlement Agreement and Recovery of Temporary Rates* that included a schedule of unbilled temporary rates in the amount of \$29,363.04. Today the Commission's Staff identified an error in the schedule which used a quarterly fixed rate of \$155.54 per unmetered customer per quarter.

The correct amount specified in the Company's Tariff (6th Revised Page 12) and used in its bills is \$156.39. This resulted in an understatement of the total revenue in Column (s) and the calculation in Column (u).

I apologize for this inadvertent error and thank the Commission Staff for its careful and timely review. The Company has corrected the error and I enclose a revised spreadsheet showing the total unbilled temporary rates of \$29,570.36. Because the total difference is minor, \$207.32, I have not revised the memorandum filed on January 6, 2016. Lakes Region will mark this schedule as an exhibit and its witnesses will be prepared to answer any questions on this issue.
