CORRECTED HEARING EXAMINER'S REPORT

On June 25, 2015, the Commission issued Order No. 25,795 in the above-captioned docket. Order No. 25,795 suspended a tariff and scheduled a hearing. In the ordering clause, the hearing on the proposed tariff was scheduled for July 8, 2015 at 10:00 a.m., and, in fact, the hearing was held on that day. Order No. 27,595, however, also stated in the summary of the Order that the hearing would be held on July 9, 2015 at 9:00 a.m. Because of this error, at the July 8th hearing, the Chairman assigned me to serve as hearing examiner on July 9th, in the event that any parties appeared for the hearing at that time.

I arranged for Attorney Gary Epler, the chief regulatory counsel for Unitil Energy Systems, Inc., to participate telephonically in the July 9th hearing. The record will show that no parties other than Attorney Epler appeared for the hearing, and the record in this proceeding is now closed. The Commission may now deliberate the filing.
