Re: DE 15-302, Residential Renewable Energy Incentive Program  
Revised Application Availability and Off-Grid System Eligibility

To Interested Persons:

A revised form of Step 1 application for the Residential Renewable Energy Incentive Program is now available on the Commission's web site, <http://www.puc.nh.gov/Sustainable%20Energy/RenewableEnergyRebates-SREG.html>. This application form is to be used for projects eligible for the modified incentive payment level of \$0.50 per watt up to a maximum of \$2,500.00, or 30% of the total system cost, whichever is less. Pursuant to Order No. 25,813 issued on September 18, 2015, this reduced incentive payment level is effective for all program applications received after 4:30 pm on October 2, 2015.

The Step 1 application form also has been revised to provide that off-grid renewable energy systems will not be eligible for the program incentive payment, based on the Commission's recent legal interpretation that RSA 362-F:10, V precludes program eligibility for any system that would not qualify as a Class I or Class II source of electricity for purposes of the Renewable Portfolio Standard because it would not be interconnected to an electric distribution company distribution system.

The Commission observes that this revision will also achieve greater consistency in the terms and conditions applicable to various incentive programs administered with funding from the Renewable Energy Fund (REF) and is consistent with Order No. 25,813 by assuring that limited funding from reduced REF balances is expended in the most cost-effective manner.
