Re: DE 10-024, Fiscal Year 2017 Renewable Energy Fund Program Budget Adjustments

To Whom It May Concern:

On April 25, 2017, Staff filed a memorandum requesting approval to amend certain Renewable Energy Fund (REF) program budgets based on current program demand and projected spending for the remainder of fiscal year 2017 (FY17). The recommended reallocation of funds will have no impact on the balance of funds allocated between the residential and non-residential program sectors (see RSA 362-F:10) and meets other statutory allocation requirements. Specific program adjustments are as follows:



In addition, Staff recommended that all program applicants with expired step 1 applications be notified via email that they will have 10 business days to submit a completed step 2 application or request an extension. If no action is taken by the applicant within 10 business days, the reserved funds will be "released" and made available to other program applicants in the queue. Further, Staff recommended that the Commission authorize the creation of individual program waiting lists to establish priority for the processing of applications if and when additional funding becomes available once individual program funds are fully reserved.

Please be advised that the Commission has approved the REF Residential and Commercial and Industrial program budget adjustments set out in Table 1 and Table 2 as proposed by Staff in its April 25, 2017 recommendation. The Commission further authorizes Staff to establish program waitlists when program FY17 budget funds become fully reserved. In consideration of the establishment of individual program waitlists, the Commission reminds applicants to send original, signed applications to the Commission; electronic applications will not be accepted.
